- 4.2 Steve reminded residents that the cannot control who lives in a house nor give a violation for lawful activity at a house. If residents have concerns, they need to call the non-emergency police number 444-7000, or if it is an emergency call 911.
- 4.3 If you have a complaint about another resident in the community, they need to be in writing and the HOA cannot act on anonymous calls.
- 4.4 RV's/Trailers can only be there for loading and unloading. Unless you received prior HOA approval.
- 4.5 The street repair number is (719) 385-2489
- 4.6 Since the HOA cannot enforce parking and expired tags on a public road. Steve reminded residents that they can call (719) 444-7891
- 4.7 Please remember owners are responsible for the dead trees in their backyard as well.
- 4.8 If you have a complaint on a barking dog the best place to call is the Humane Society. They can come same day and give a warning to the owner. The number is 719-473-1741.
- 4.9 Reminder the streets are not plowed in the winter and residents need to be careful. You will also need to call the street division for road repair as well. You can also do this on the GoCOS app.
- 4.10 New system allows residents to check their balances, pay online and submit acc's online. All of this is documented in the homeowner files that homeowners can see. It also allows homeowners to see violations they may have and communicate with us if they have corrected the issue. Homeowners can get he CINC app as well.
